## **ONE TIME FIELD MAINTENANCE FEE**

*The One Time Field Maintenance Fee is collected from MAM members and used to help off set the clubs expense for the continued maintenance of the MAM flying field and equipment.*

**One Time Field Fee** is \$200 per member (Associate members are not required to pay the One Time Field Maintenance Fee but have NO Voting Rights) and may be paid over a 5 year period. (\$25 the first two years, \$50 the next three years.)
